GENERAL COMPETITION INFORMATION

- The purpose of the Extemporaneous Public Speaking Competition is to enhance the skills of youth by: (a) researching and gaining knowledge of a wide variety of agricultural content and (b) practicing the ability to think and speak under pressure without prior rehearsal.
- A panel of judges will use a scoresheet to evaluate the contestants in forming a non-prepared speech based on verbal and non-verbal communication skills.
- There will be two classes of contestants, according to age Juniors and Seniors.
- Speech topics will be randomly drawn by the contestant in a category of agricultural systems.
 - 1. AgriBusiness Systems
 - 2. Agricultural Education
 - 3. Animal Systems
 - 4. Biotechnology Systems
 - 5. Environmental Service Systems
- 6. Food Products & Processing Systems
- 7. Natural Resources Systems
- 8. Plant Systems
- 9. Power Structural & Technical Systems

ELIGIBILITY

- 1. This contest is open to all youth, ages 8 18 years of age as of September 1st of the current year.
- 2. Membership in 4-H or FFA is not required to enter.
- 3. Contestants must not have won a state or national-level extemporaneous public speaking event prior to this competition.
- 4. Entries will be limited to the <u>first 20 speakers</u> who enter online, regardless of age. Parking and admission credentials will be mailed to contestants who enter by August 15, 11:59 p.m. Late entries submitted after August 15 will not receive parking or admission to enter the fairgrounds and will be responsible for the purchase of parking and admission.
- 5. Entries will be accepted until all 20 contestant slots are filled or by September 1, whichever comes first.
- 6. Accepted entries will be confirmed via e-mail provided when entering the competition.

CLASSES

- 1. Juniors ages 8 years through 13 years old
- 2. Seniors ages 14 years through 18 years old

ENTRY FEE INFORMATION

- \$10 entry fee per contestant entered online by September 1, 2022. No entries will be accepted after September 1.
- \$10 processing fee per contestant



- Entries submitted and paid for by August 15 will include: one single-day general admission ticket and one single-day parking pass to the Oklahoma State Fair (OSF). (Contestants entering after August 15 will not be eligible for complimentary admission nor parking and will have to purchase).
- Refer to Livestock Show Rules and Regulations for information regarding additional fees and admissions.

COMPETITION FORMAT

- 1. The Junior class will compete first, starting at 9 a.m. One 30-minute break for judges will be included in the schedule.
- 2. **Attire:** Contestants should wear business attire or attire representative of the group or club they are representing (i.e., official 4-H or FFA attire).
- 3. Arrival:
 - a. One single day admission and parking pass will be mailed to all contestants entered online by August 15. Any guests accompanying contestants will be required to purchase admission in advance or at the gate upon arrival.
 - b. Contestants and accompanying guests will need to enter (walk through admission only) OKC Fairgrounds via Gate 7 or Gate 8, both opening at 6:30 a.m.
 - c. Contestants must arrive and check-in by 8 a.m. in Barn 3 Meeting Room (across the south-hall of the Capital City Auditorium) for an informational session. Contestants arriving late to check-in will be subject to penalization.
- 4. Upon check-in, contestants will randomly select a number to determine speaker order in each age division. Each speaker will then be given a pre-determined time to arrive in the holding room, Barn 3 Meeting Room.
- 5. In the holding room, contestants will have 30 minutes to:
 - a. Randomly choose a topic/question within their chosen category of agriculture
 - b. Research their topic for speech preparation
- 6. **Approved research material** to bring or use in holding room:
 - a. Using the computers in the holding room provided by OSF
 - b. Bringing up to five (5) printed material documents (such as books, magazines, or printed internet research)
 - c. Contestants may not use notes or speeches from a previous competition or by another speaker
 - d. Contestants may bring blank flashcards to take notes on for their speech; however, the use of flashcards will be a criterion for points if they provide a distraction from the speech.
- 7. Official competition staff will be present in the holding room to monitor preparation. They will also introduce speakers and their chosen topic before the speaker begins their speech.
- 8. Speeches will be presented in the Capital City Auditorium and must be 5-7 minutes long. Speeches outside of this time frame will be given a 1-point deduction for every second under or over the time limit.
- 9. The Capital City Auditorium will be open to all guests and spectators to watch presentations. However, contestants will not be allowed to enter the Auditorium before their scheduled presentation time. Contestants who violate this rule will be disqualified. After the completion of their speech, contestants are welcome to watch other speakers. All cell phones must be muted prior to entry.
- 10. Assistance, coaching, suggestions, or any other form of guidance from anyone in the audience during the presentation is prohibited. Such actions from the audience may result in disqualification of the contestant.
- 11. **Props:** The use of props (i.e., posters, live/fake animals, electronics, or objects of any kind) is prohibited and will result in disqualification from competition if used.
- 12. Following the completion of their speech, each contestant is given three additional minutes for questions from the judges relating to their speech and chosen topic. Contestants will be scored on their capability to answer the judges' questions.

JUDGING INFORMATION

- The competition will consist of two to three judges who will consist of a combination of agricultural industry experts, presenting sponsor representatives, OSF employees, or other such individuals who provide agricultural and public speaking knowledge, who can also provide impartial evaluation of each participant.
- A timekeeper will record the speaker's time. There will be no time warnings for the contestant.
- Judges will have a maximum of three minutes to ask the speaker questions.
- After the completion of each contestant, judges will use the provided rubric to score each participant. The contestants will then be ranked based off of their total score, including any time refractions.
- Judging sheets will be compiled at the end of the competition to determine the official contestant ranking.



AWARDS/PREMIUM INFORMATION

- Awards will be given to first through fifth places in each division.
- Ribbons will be awarded to sixth through tenth place in each division.
- Premiums will be distributed as noted below:
